RE: REQUIRMENTS

- **Phytosanitary certificate, USDA & ODA Info**
 - Phyto cert is good for 30 days from issuance.
 - Phytosanitary Certificate and Issuance Tracking (PCIT) system

 - ODA Phytosanitary inspection, when ready email PlantHealth@oda.state.or.us

Required Documentation: (from 1/22/20 email from Elizabeth)

- Oregon hemp grower/handler registration
- Oregon agricultural hemp seed producer registration (if you produced the seeds)
- Regulatory test results indicating that the seed was harvested from hemp plants (ie., pre-harvest results, no more than 0.3% THC)
- Tests costs \$70 and requires about 100 seeds.

Possible Additional Requirements: (from 1/22/20 email from Elizabeth)

- If there are additional requirements for treatment (ie., fungicides, hot water), those will need to be officially verified by the Department. Email Kevin Bailey (kbailey@oda.state.or.us) to set up a treatment verification. Treatments should be applied after the phytosanitary inspection if possible.
- Some counties also require ISTA certification - this is done by a third party (like OSU or Agriseed Testing) - <https://seedlab.oregonstate.edu/ista-certificates/ista-basic-information>.

ISTA is the International Seed Testing Association. The OSU Seed Lab is an ISTA Accredited Member Lab. Learn more about ISTA by visiting their website.

- **Import permit**
 - Issued by importing country
 - China Import Permit info
 - There's a limited amount of import licenses and you should make sure that your Chinese importer has one prior to exportation.
 - Import applications should be made to MOFCOM (the Ministry of Commerce).
- **Pest & Disease (P&D) visual inspections**
 - Conducted by ODA
 - We send sample to Elizabeth Savory
 - Pest & Disease (P&D) visual inspection: 1-2 days
- **COA** for Total THC from ODA approved lab
- **Certificate of Origin** per export order given by Chamber of Commerce
